RESOLUTION 2013-57 OF THE SOUTH JERSEY TRANSPORTATION AUTHORITY AUTHORIZING THE APPOINTMENT OF PARKER MCCAY, OF MOUNT LAUREL, NEW JERSEY TO PROVIDE BOND COUNSEL SERVICES (CONFLICT) TO THE AUTHORITY

The Authority currently has a contract with Wolff & Samson of West Orange, New Jersey, for the provision of Bond Counsel Services. There is a need for the Authority to engage Conflict Bond Counsel Services for instances when its current Bond Counsel cannot provide representation due to a conflict. On May 6, 7, and 8, 2013, the Authority publicly advertised a Request for Proposals for Bond Counsel Services (Conflict). Six (6) proposals were received by the Authority on May 10, 2013. The Consultant Selection Committee ("CSC") met on May 13, 2013, reviewed the proposals for Bond Counsel Services (Conflict) and recommends Parker McCay P.A. of Mount Laurel, New Jersey as they were determined to have offered the best proposal to serve the interests of the Authority. The recommendation of the CSC is to appoint Parker McCay P.A. of Mount Laurel, New Jersey, to provide Bond Counsel Services (Conflict) for a period of approximately seventeen (17) months.
